How will the assessment results be shared with parents and guardians?



Information for Parents and Guardians





What is the purpose of this assessment?

This assessment will gather information about individual student performance in literacy (reading and writing) and mathematics/mathématiques. The results will provide

- teachers with information to inform instructional planning;
- parents and guardians with information on their child's performance;
- the Department of Education and Early Childhood Development and the school system with information to inform educational decisions.

Who participates in the Literacy and Mathematics in Grade 3 assessment?

Grade 3 English program students enrolled in Nova Scotia public schools participate in this assessment. Students with an individual program plan (IPP) in English language arts or mathematics may participate in the subject area(s) of their IPP if the student planning team determines this would be appropriate.

Who participates in the Mathématiques in Grade 3 assessment?

Grade 3 French immersion students write only the mathematics portion of this assessment as they only begin formal English language arts instruction at the beginning of grade 3; the mathematics portion of the assessment is written in French. Students with an individual program plan (IPP) in mathématiques may participate if the program planning team determines this would be appropriate.

When is this assessment administered?

The assessment will be administered on four mornings between May 13 and May 28, 2024.

What is included in the Literacy sections of this assessment?

Students will independently read and answer comprehension questions about information texts, narrative texts, poetry, and visual texts. Students will also independently complete two writing tasks.

What is included in the Mathematics/ Mathématiques section of this assessment?

Students answer questions in the following areas: number, patterns and relationships, measurement, geometry, and statistics. Skills in calculation, estimation and problem solving are embedded in the assessment.

How can I help my child prepare for this assessment?

No special preparation is necessary. A positive, relaxed attitude will help your child do their best. What your child has been learning in school has been preparing them for the assessment.

Who develops and scores this assessment?

Nova Scotia Assessments are developed by Student Assessment and Evaluation, Department of Education and Early Childhood Development, in consultation with teachers in Nova Scotia.

Student writing tasks will be scored by teachers during scoring sessions led by Student Assessment and Evaluation. Selected response items (where the student chooses a response from multiple options) will be scored electronically at the department.
